Our management team continuously attends training sessions to enhance their expertise, which they then share with our staff. 




# EARLY HEAD START IMPACTS ON CHILDHOOD DEVELOPMENT

#### Why It Matters?

Early Head Start (EHS) programs promote **physical, cognitive, language and communication, and social-emotional development** of infants and toddlers through safe and developmentally enriching caregiving. Age expectancy(AE) is an important indicator of childhood development. EHS helps to create awareness and to implement this information with the families we serve.



#### **Chart Key:**

- Maintained AE Children who maintained or increased rate of development within AE development
- Increased to AE Children who increased rate of development from below to AE development
- Maintained or Increased to Above AE Children who increased rate of development from below to AE development
- Increased Significantly but Below AE Children who made significant increases in rate of development but continue to be below AE development
- Continued or Decreased to Below AE Children who show below AE or dropped to below AE development
